

Terms of Service

CemSites.com is a site specifically for Cemeteries, Memorial Gardens, Funeral Homes, their employees or contractors, and anyone else involved in the death care industry.

The following terms and conditions govern all use of the CemSites.com website and all content, services and products available at or through the website. The Website is owned and operated by CemSites.com. ("CemSites"). The Website is offered subject to your acceptance without modification of all of the terms and conditions contained herein and all other operating rules, policies and procedures that may be published from time to time on this Site by CemSites (collectively, the "Agreement").

Please read this Agreement carefully before accessing or using the Website. By accessing or using any part of the web site, you agree to become bound by the terms and conditions of this agreement. If you do not agree to all the terms and conditions of this agreement, then you may not access the Website or use any services. If these terms and conditions are considered an offer by CemSites, acceptance is expressly limited to these terms.
